"The North East Trillium competitions are sanctioned as Silver or Silver/Bronze competition members of Equestrian Canada, 308 Legget Drive, Suite 100, Ottawa, Ontario K2K 1Y6 and are governed by the rules of Equestrian Canada." (Article A602.1)

# **Equestrian Canada Statement of Principle**

Equestrian Canada (EC), the national equestrian federation of Canada supports adherence to the humane treatment of horses in all activities under its jurisdiction.

All persons shall be committed to:

- upholding the welfare of horses, regardless of value, as a primary consideration in all activities;
- requiring that horses be treated with kindness, respect and compassion, and that they never be subjected to mistreatment;
- ensuring that all Equestrians including owners, trainers, and competitors, or their respective agents, use responsible care in the handling, treatment and transportation of their own horses as well as horses placed in their care for any purpose;
- providing for the continuous well-being of horses by encouraging the routine inspection and consultation with healthcare professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure;
- Providing current information on Code of Practice for the Care and Handling of Equines and other equine health and welfare initiatives;
- continuing to support scientific studies on equine health and welfare;
- requiring owners, trainers and competitors to know and follow their sanctioning organization's rules, and to work within the industry regulations in all equestrian competitions: and;
- actively promoting the development and adherence of competition rules and regulations that protect the welfare of the horse.

The standard by which conduct or treatment will be measured is that which a person who is informed and experienced in generally accepted equine training and competition procedures would determine to be neither cruel, abusive not inhumane.

## **Required Prize List Information**

- 1) Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location." (Article A602.5)
- 2) "Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC Constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition." (Article A602.7)
- 3) Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book. (Article A602.2)
- 4) All competitors and owners are required to become Sports License holders of Equestrian Canada and to become a member of the Ontario Equestrian. To accumulate points in order to be eligible for zone year end awards and/or to represent the zone at the Trillium Championships the competitor must be a member of the North East Zone of the Trillium Hunter Jumper Association (THJA) and must participate in a minimum of four (4) shows. Owners must be THJA members but not necessarily of the North East zone.

- 5) Except for non-core classes in Bronze Licensed shows, all Canadian entries are required to hold an EC Horse Recording and have paid the Horse Recording annual Activation Fee.
- 6) All horses attending Equestrian Canada sanctioned competitions must have met the requirements of **Article A519**, **Vaccinations** as follows;

"All horses attending Equestrian Canada sanctioned competitions must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not in compliance with this rule may be asked to leave event site at the discretion of Competition Management.

The frequency of vaccine administration should be as recommended by the vaccine manufacturer or veterinarian. It is recommended that vaccines be administered by or under the direction of a veterinarian. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements.

In the case of a horse that is unable to receive either of the vaccines, a letter from a veterinarian on official letterhead must be provided with the entry form, stating the horse cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested."

For the purposes of the North East Trillium 2020 entries, proof of vaccinations must be submitted prior to or at the time of entry of the horse at the competition. Acceptable proof will be an invoice from a recognized veterinarian identifying the horse, the date of administration and the vaccines administered. If the vaccine is administered by someone other than a verinarian we will require proof of purchase of the vaccines and an affidavit from the person doing the administration, cosigned by the owner/lease of the horse indicating the date of the administration.

Temporary EC sport licenses and horse registration will be available for purchase at each horse show. Without memberships you will not be allowed to compete at any Trillium Show. Exhibitors competing under temporary licenses and memberships will **not** be able to accrue points at that show.

For 2020, competitors and owners showing in the North East Trillium shows must also have at least a **SILVER** Equine Canada Sport License to compete in core Divisions and classes. If the show has a Bronze license, a Bronze Sport License will be sufficient to allow competitors to compete in the non-core (Bronze level) classes and divisions.

Those competitors lacking these memberships must pay the full cost of temporary memberships and horse registration before being allowed to show. For horses without a current EC Horse Recording Number, a temporary registration must be purchased. No points will be accrued under temporary memberships or horse registrations.

Photocopies of all memberships and Horse Recording Information (or copies of emails) must be attached to each entry form.

Current Horse Recordings are required for all horse in core divisions except Hack Division.

# Reminders

- 1) The "A", "B" and "C" Equitation <u>under saddle</u> classes will be held following the Pony Pleasure Hack class. "C", "B" and "A" Equitation classes over fences may remain "Open Card" at the discretion of each show management. It can be much more efficient but is does not work with all show schedules. If an "Open Card" system is to be used, participants must be informed prior to the show day of the set schedule. Riders in Equitation classes must compete with the Horse's number not a separate rider number.
- 2) See the attached 2020 Trillium Core Division Specifications for the classed and division to be offered at the Silver level in all shows. And see 2020 Non-core Division Specifications for other classes and divisions.
- 3) It is likely that some shows will run with a single ring and judge both days, others may have a separate jumper and hunter ring on Saturday. Shows will start their program on Friday afternoon at 4:00 pm, with the 0.75 m Jumper Division, followed usually with the remaining Jumper Divisions. Shows may also add other classes to their program. It is the responsibility of the riders and trainers to be aware of the details of shows they plan to enter. Programs will be published and available on our website at www.nethja.com
- 4) Late entry fees will apply for all shows. For the first show (Trevella Stables Trillium May 29 31) entries will be considered late if they are not received by Monday May 25th. Entries may be sent in by email. They must be complete with all membership numbers etc. to be considered on time. Copies of membership forms and proof of vaccination can be handed in at the time of on-site registration.

# GENERAL RULES AND REGULATIONS

Every class herein is covered by the Rules and Specifications of the current rules of EC and will be held and judged in accordance with the said rule book. Miscellaneous classes will be as specified in the attached 2019 Trillium Core Division Specifications and 2019 Non-core Division Specifications. Should any questions arise that are not provided for in the rule book, they shall be referred to the Organizing Committee and their decision will be final. The Organizing Committee reserves the right to refuse entry of members not in good standing, and to cancel, postpone or re-schedule any class for conditions they deem reasonable

**Medical/Vet scratches** – to qualify for a medical (rider) or vet (horse) scratch you and/or the horse must be on site and on the judge's card. You must provide the organizing committee with appropriate documentation concerning the reason for the withdrawal of the entry from the class or division.

The Organizing Committee shall comprise: the judge, steward, course designer and the show manager.

# **Core Trillium Circuit classes**;

The following are **Core Level** Divisions and classes; Developmental Hi/Lo Hunter, Children's/Adult Amateur 2'6" Hunter, Modified Children's/Adult Amateur 2'9" Hunter, Low Hunter, Trillium Hunter (Low/High), Adult Amateur Hunter, Children's 3' Hunter, Modified Pony Hunter (small, medium, large), Pony Hunter (small, medium and large), Short Stirrup Hunter, Hack, Open 0.90 m Jumper, Open 1.0 m Jumper, Trillium Jumper, Trillium Jumper Medal, My First Trillium Hunter Medal Modified 2'9" Child/Adult Hunter Medal, Children's Medal, Adult, A, B, and C Equitation. Participants in any of these must be paid up members of the Ontario Equestrian and must have at least a SILVER Equestrian Canada sport license. All horses used in any **core** Hunter, Jumper and Equitation classes must have a current, up-to-date 2020 Horse Recording activated number. Horses in Hack Division do not need horse recording numbers. For exhibitors to accrue points you must be a member of the North East THJA, horse owners must be THJA members though not necessarily in NE zone.

All other divisions and classes are miscellaneous (non-core). Competitors riding in miscellaneous divisions and classes must be members of the Ontario Equestrian and must also have the appropriate Equine Canada sport license. If you wish to accrue points towards year-end awards you must also be a member of THJA (NE region).

#### **Entry Forms**

Entry forms must be complete with all requested information. Incomplete entry forms will be subject to a late fee and **the horse/rider will be required to submit the missing information before being allowed to compete!** The entry form must have the signature(s) of the rider(s), the Owner of the horse or representative, the parent or guardian in the case of a Junior rider and of the Person Responsible for the horse. (see A801.5) The Person Responsible (PR) for a horse must be an adult who has, or shares responsibility, for the care, training, custody, and performance of the horse and who has official responsibility for that horse under EC rules. For adult entries, the PR may be either the trainer, the owner of the horse or the adult rider of the horse and must be an EC member. For Junior entries, the PR must be and adult; they may be the owner or trainer of the horse (EC membership required) or the parent/guardian of the competitor (no EC membership required).

# Local Rules and Regulations

- 1) Stabling requests must be in writing or by email, to Joseph Meuleman <u>northeastthja@gmail.com</u>, or <u>info@nethja.com</u> and <u>made 2 weeks prior to each show</u>. Stall fees <u>are non-refundable</u> and all fees must be paid to remain in good standing. Cost of stabling is to be consistent at each facility, but each show may set its own stabling cost.
- 2) Bedding and hay will be an additional cost, advance requests are appreciated when you make your stabling request.
- 3) Stabling will only be on a per event basis. There will be limited stabling available, not necessarily on the show grounds and this only if the secretary is contacted early. Overnight stabling or day stalls will not usually be available unless arranged individually with show management.
- 4) For the first show of the season the deadline for on-time entries will be the Monday prior to the show weekend and the late entry fee will be \$25. For all following shows, competitors must submit their entries at least 4 h before the first event they are entering. Failure to comply with these deadlines will result in a \$5/division post entry fee. Competitors are encouraged to email their entries at least one week prior to each event. Stabling requests must have been submitted two weeks in advance.
- 5) All entry forms **MUST BE COMPLETE** to be considered on-time, with proper signatures, complete addresses, EC/OE/THJA numbers for owners and rider(s) and Horse Recording numbers for horses. Proof of memberships and current Horse Recording Number and proof of vaccinations must be presented at the time of registration. Failure to produce these will result in disqualification. Competitors under 18 years of age must have a parent's or guardian's signature on their entry form. Adult competitors may sign their entry form as "Person Responsible" and provide their EC Number. For Junior competitors, the entry form must be signed by an adult acting as "Person Responsible", this may be the owner of the horse, the coach or trainer or the parent or guardian. The "Person responsible must have current EC membership except in the case of the parent or guardian where no membership is required.
- 6) We cannot sell EC Silver sport licenses. We can sell temporary memberships for the show, BUT no points will be awarded. Competitors may show in two different zones but it must be with different mounts. THJA memberships must be purchased for each zone in which you compete.
- 7) A photocopy of all memberships and licenses, proof of vaccinations and Horse Recording information, or email verification of the same, should be attached to your entry for each show unless already on file with the show office.
- 8) Entries must be accompanied by either cash (in full) or by an open cheque at the time of entry.
- 9) Entry fee refunds must be authorized by the Organizing Committee and/or a veterinarian. In the following circumstances;
  - a) Cancellation of the entire competition as per General Regulations A308. All entries and fees paid must be refunded entirely within 30 days. Cancellations made due to extraordinary circumstances (e.g. natural disasters, storms, accidents or emergencies) will be addressed on a case by case basis with Equestrian Canada
  - b) In the event that a class or the remainder of a class is cancelled and cannot be rescheduled within the duration of the competition, the exhibitor will be reimbursed the class fee.
  - c) Each prize list must contain the cancellation and refund policy of the organizers. A competition receiving written confirmation from a competitor of cancellation of their entry before the closing date will refund the competitor 100% of class fees paid, except the administration fee set by the competition and applicable stall reservations as identified in the prize list, which may be retained by the competition organizer. Fees collected on behalf of other organizations or entities (including, but not limited to: drug fees, discipline levies and temporary fees) must be returned to competitors.
  - d) Credits and refunds. Refunds may be offered in the form of a credit towards entry at a future competition of the same organizing committee on a dollar for dollar basis, if acceptable to the competitor. Credits may be offered by the competition as a choice to the competitor, but may not be the sole option.

- 10) The Judge's decision is final.
- 11) Age divisions are as follows: note the age of a rider on January 1 of the current year will determine the rider's classification for the entire following year.

**Adult (Senior)** from the beginning of the calendar year you turn 19. (For 2020 those born in 2001 or earlier) **Junior "A"** from the beginning of the calendar year in which you reach the age of 16 to the end of the year in which you turn 18. (For 2020 those born in 2002, 2003, 2004)

**Junior "B"** from the beginning of the calendar year in which you reach the age of 13 to the end of the year in which you turn 15. (For 2020 those born in 2005, 2006)

**Junior "C"** until the end of the year in which you turn 12 (For 2020 those born in 2008 or later).

- 12) All riders must wear approved protective headgear secured with a safety harness permanently affixed to the helmet at all times while riding anywhere on the competition grounds at all Equestrian Canada sanctioned competitions.
- 13) All Junior competitors must wear approved head gear with harness fastened for the jog.
- 14) Senior riders entering into Amateur classes must possess a current EC Amateur designation on their current Sport License.
- 15) In classes for ponies, ponies may only be ridden by Junior riders. Junior 'A' riders may only ride "A" (large) ponies
- 16) Adult Amateur riders may ride "A" ponies in Adult Amateur classes. May not be ridden by a Junior at the same competition.
- 17) Protests must be made within 48 hours of the occurrence, to the secretary or the Organizing Committee.
- 18) Protests must be in writing, signed and with a \$100.00 deposit. The deposit will be refunded if the protest is upheld.
- 19) In Hunter Divisions, competitors must complete at least one Over Fences Class to be eligible for the corresponding Hunter Under Saddle Class. When jogging, a junior must jog a junior horse and similarly an amateur must jog an amateur horse (article G401.6).
- 20) Hors Concours entries. Once a horse has shown hors concours, it may not compete in any other event in the same ring on the same day. Hors concours entries are not permitted in Hunter Divisions (article G401.7). Hors Concours entries are permitted at the discretion of the organizing committee in the jumper divisions (article G501.2).
- 21) At the discretion of the Organizing Committee, competitors may be required to ride the over fences portion of the hunter divisions back-to-back.
- 22) Championship points for the divisions to which they apply will be available at the secretary's booth. Champion and Reserve Champion will be awarded after each division.
- 23) All dogs on the show grounds must be kept under control, preferably on a leash.
- 24) Proof of a negative Coggins test may be requested by each show facility but if not specified it is only a recommendation. Proof of Coggins is up to the individual shows.
- 25) **Motorized Vehicles:** The use of motorized vehicles (ATV's, motorbikes, etc., is restricted to licensed operators ONLY and may, at the discretion of the show management, be restricted entirely on the show grounds.
- 26) **Conduct of Jumper Divisions** While details may vary for individual shows, it is proposed that we will start with the three classes for the 0.75 m Jumper Division, to be followed by the other three Jumper divisions as follows; Start with 1<sup>st</sup> class of the 0.90 m Jumper, then 1<sup>st</sup> class of 1.0 m Jumper and 1<sup>st</sup> class of the 1.10 m Jumper; follow with 2<sup>nd</sup> class of the 1.10 m Jumper, 2<sup>nd</sup> class of the 1.0 m Jumper and then the 2<sup>nd</sup> class of the 0.90 m Jumper; follow with 3<sup>rd</sup> class of the 0.90 m Jumper, 3<sup>rd</sup> class of the 1.0 m Jumper and then 3<sup>rd</sup> class of the 1.10 m Jumper. The 1.0 m Jumper Equitation Class would follow. No clear rounds for core division classes but riders may enter one or more classes in the 0.75 m Division as preparation. Jumper horse/rider combinations are restricted to 2 Core Divisions at consecutive heights; 0.90 m and 1.0 m or 1.0 m and 1.10 m. Any horse/rider combination may choose to show in a clear round trip at 0.90 m.
- 27) Eligibility in the miscellaneous divisions: (also see 2019 Non-core Specifications)

Miscellaneous and Non- Core Classes and Divisions

These non-core Divisions require only an Equestrian Canada Bronze sport licence and Ontario Equestrian membership. The horses or ponies do NOT require a horse recording number. To qualify for yearend North East Trillium Awards, the riders must have THJA memberships and participate in a minimum of 4 shows.
